

ORDINANCE NO. 43

**AN ORDINANCE ESTABLISHING PERMANENT GRADES
ON PORTIONS OF VARIOUS STREETS HEREIN SPECIFIED**

BE IT ORDAINED BY THE BOARD OF SUPERVISORS, CERRO GORDO COUNTY, IOWA

SECTION I: That for the purpose of regulating future construction in, upon, or along the streets hereinafter designated, thereby, and the same is hereby established, a schedule of permanent grades in accordance with the elevations listed in Section IV hereof.

SECTION II: That said elevations conform to the Cerro Gordo County Elevation Datum, and in particular to the bench marks listed on plans entitled "Lee Street Paving Project", as prepared by WHKS & Co., Consulting Engineers and Planners, Mason City, Iowa.

SECTION III: That previous ordinances or portions thereof in conflict with the elevations herein set forth are herewith repealed.

SECTION IV: That the following elevations shall apply at the locations designated and all future street, sidewalk and driveway improvements shall be constructed in conformity therewith.

NOTE: All elevations are tangent line elevations. Point of tangent intersections are indicated by an asterisk (*). The length of the vertical curve is shown in 100-foot stations to the right of the asterisk. For the vertical curvature corrections, see the Plans referred to in Section II hereof.

SECTION V: If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

SECTION VI: This ordinance shall be in effect after final passage, approval and publication as provided by law.
