(Transfer #1344). The sum of Nine hundred twenty-five thousand (\$925,000.00) dollars is ordered to be transferred from the Rural Services Fund to the Secondary Road Fund, effective April 14, 2015. (Transfer #1343). The Auditor is directed to correct his books accordingly and to notify the Treasurer of this operating transfer. The above and foregoing resolution was approved by the Board of Supervisors of Cerro Gordo County, Iowa on the 14th day of April, 2015. Motion passed unanimously.

A Resolution authorizing the issuance, and levying a tax to pay the Notes; and Approval of the Tax Exemption Certificate.
