(Transfer #1354). The sum of Seventeen hundred forty 00/100 (\$1740.00) dollars is ordered to be transferred from the Meservey O & M Fund to the Meservey Reserve Fund, effective June 21, 2016. (Transfer #1355). The sum of Twenty eight hundred fifteen 00/100 (\$2815.00) dollars is ordered to be transferred from the Meservey O & M Fund to the Meservey Department Fund, effective June 21, 2016. (Transfer #1356). The sum of Two million five hundred seventy-five thousand 00/100 (\$2,575.000.00) dollars is ordered to be transferred from the General Supplemental Fund to the General Fund, effective June 21, 2016. (Transfer #1357). The Auditor is directed to correct his books accordingly and to notify the Treasurer of this operating transfer. Motion passed unanimously.

Urdahl made a motion, with Dougherty seconding, to approve a fireworks permit for Rick Ott. Motion passed unanimously.
