

PROCEEDINGS OF THE BOARD OF SUPERVISORS
August 4, 2020

The Board of Supervisors of Cerro Gordo County, Iowa, met in regular session pursuant to adjournment. Present: Chairman Tim Latham, Vice Chairman Casey Callanan, Supervisor Chris Watts and various members of the public.

Chairman Latham convened the meeting at 10:00 a.m.

Watts moved with Callanan seconding, to approve today's agenda and the meeting minutes for the July 28 regular session and the July 28 special session. Motion passed unanimously.

Public comment session was held. Watts, Callanan, and Latham took a moment to remember Bob Amosson, former County Supervisor, who recently passed away.

Callanan moved with Watts seconding, to approve claims. Motion passed unanimously.

Callanan moved with Watts seconding, to abate drainage assessments in DR26 for United States of America totaling \$538, in DR31 for United States of America totaling \$88, and in DR21H for United States of America and US Fish & Wildlife totaling \$2,108. Motion passed unanimously.

Callanan moved with Watts seconding, to suspend AY2019 taxes, pursuant to Section 427.9, of \$312.00 for parcel 07-03-353-021-00, of \$850.00 for parcel 07-04-230-007-00, of \$1,036.00 for parcel 07-04-411-002-00, of \$1,440 for parcel 07-08-402-001-00, of \$1,102.00 for parcel 07-09-130-004-00, of \$758.00 for parcel 07-10-480-005-00, of \$1,050.00 for parcel 07-04-274-017-00, of \$1,352.00 for parcel 07-15-253-022-00. Motion passed unanimously.

Watts moved with Callanan seconding, to abate AY2019 taxes of \$542.00 and special assessment of \$79.00 on parcel 07-09-209-009-00, of \$478.00 for parcel 07-10-201-003-00, of \$110.00 for parcel 07-15-102-006-00, of \$162.00 for parcel 07-15-102-007-00. Motion passed unanimously.

Callanan moved with Watts seconding, to approve the reports from the Zoning Director and the Environmental Health Service Manager concerning Manure Management Plans filed by HE Trettin, Inc.- Finisher 3 (site #62244) and forward to the DNR. Motion passed unanimously.

Watts moved with Callanan seconding, to authorize the Chair to sign the agreement between NIACOG and Cerro Gordo County. Motion passed unanimously.

Callanan moved with Watts seconding, to uphold the denial of the Teamsters Union grievances heard by the Board on June 23, 2020. Motion passed unanimously.

Watts moved with Callanan seconding, to adjourn at 10:11 a.m. Motion passed unanimously.
