Watts moved with Meacham Ginapp seconding, to adopt Resolution 2023-49, A RESOLUTION APPROVING FINAL PLAT FOR "P5 SUBDIVISION, CERRO GORDO COUNTY, IOWA" WHEREAS, the Planning and Zoning Commission of Cerro Gordo County, Iowa, on the 4th day of August, 2022, duly approved the Final Plat for "P5 Subdivision, Cerro Gordo County, Iowa," and WHEREAS, said Plat appears to comply with all statutes of Iowa and ordinances of Cerro Gordo County relative to plats of additions and subdivisions. NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Cerro Gordo County, Iowa. Motion passed unanimously.

Meacham Ginapp moved with Watts seconding, to adopt Resolution 2023-50, WHEREAS, the Cerro Gordo county Planning & Zoning Commission, after study has recommended that the change of zoning classification of a certain area hereinafter described, upon the application of Mitchell J. Plagge & Rebecca J. Plagge, be made, and WHEREAS, the final public hearing has been held with notice as required by law. NOW, THEREFORE, BE IT RESOLVED by the Cerro Gordo County Board of Supervisors that Ordinance No. 15, Article 5.2, of the Zoning Ordinance of Cerro Gordo County, Iowa, is hereby amended by changing the district boundaries thereof so as to change the classification of the following described property from A-1 Agricultural District to A-2 Agricultural Residence District on the following described real estate, to-wit:

Lots 1 & 2, P5 Subdivision, Cerro Gordo County, Iowa Motion passed unanimously.

County Engineer Billings provided an update.

Meacham Ginapp moved with Watts seconding, to adopt Resolution 2023-51, WHEREAS, the Iowa Department of Transportation has adopted Administrative Rule 761-Chapter 164, which created the Traffic Safety Improvement Program to allow for funding to be provided to local jurisdictions for eligible traffic safety improvement projects; and WHEREAS, traffic crash history shows the existing alignment on S-62 entering the Town of Rock Falls from the south is a problem area and these accidents could be reduced with appropriate realignment of S-62 and additional safety features; and WHEREAS, the Town of Rock Falls has a population under 500 and Cerro Gordo County is responsible for the S-62 extension through the town; and WHEREAS, the Cerro Gordo County Engineer recommends that the application be submitted to the Iowa Department of Transportation for possible Traffic Safety Funding of the above said project. NOW, THEREFORE, BE IT RESOLVED that the Cerro Gordo County Board of Supervisors endorses the above said project and will authorize maintenance of the improvement after it is constructed; and BE IT FURTHER RESOLVED that the Chairperson of the Cerro Gordo county Board of Supervisors be authorized to sign the said application and direct the Engineering

Department to submit the same to the lowa Department of Transportation for Traffic Safety Improvement Funding. Motion passed unanimously.

Watts moved with Meacham Ginapp seconding, to approve reports from the Planning & Zoning Administrator and Environmental Health Service Manager concerning Manure Management Plan Updates for Christiansen Farms Midwest, LLC- Site F117 (#65151), Christiansen Family Farms- Site F46 (#59541), Christiansen Family Farms- Site F45 (#59538), EJ Pork- Sheldon's Site (#58266), and C.B. Neel & Sons (#63839) and forward to the DNR. Motion passed unanimously.

Watts moved with Meacham Ginapp seconding, to adjourn at 10:18 a.m. Motion passed unanimously.
